HEALTH & SAFETY AWARENESS







WHO ATTENDS

This Health & Safety Awareness course is for you if you're considering or are already working within the construction and civil engineering industry.

COURSE LENGTH

This course takes 1 day to complete.

COURSE DETAILS

This course highlights potential hazards when working on site and provides practical advice on keeping yourself and your colleagues safe.

It covers your individual and employer's responsibilities, including what you can do if you think anyone's health and safety is being put at risk. It is endorsed by Build UK as standard training for all operatives on site.

SSSTS - SITE SUPERVISOR SAFETY TRAINING SCHEME





WHO ATTENDS

This course is designed for those people who work in construction and want to advance their career and qualifications and become responsible for supervising a working taskforce.

COURSE LENGTH

This course takes 2 days to complete.

COURSE DETAILS

SSSTS is part of the CITB's Site Safety Plus training scheme and is endorsed by Build UK as the standard training for all supervisors working on Build UK sites.

It provides an understanding of health, safety, welfare and environmental issues as well as highlighting the legal responsibilities and the need to promote health and safety to supervise effectively.

COURSE CONTENT

At the end of the course you will have an understanding of:

- Health and safety law and how it applies to supervisors
- Your supervisory responsibilities in controlling site safely
- Risk assessments and method statements
- Effective site inductions, toolbox talks and method statement briefings
- Monitoring site activities effectively

SMSTS - SITE MANAGEMENT SAFETY TRAINING SCHEME





WHO ATTENDS

This course is for you if you're considering, or already have, responsibilities for planning, organising, monitoring, controlling and administering groups of staff e.g. site manager.

COURSE LENGTH

This course takes 2 days to complete.

COURSE DETAILS

SMSTS covers all relevant legislation affecting safe working in the building, construction and civil engineering industries. It highlights the need for risk assessment in the workplace, the implementation of the necessary control measures and adequate communication to sustain a health and safety culture within the workforce.

The course is endorsed by Build UK as the standard training for all construction managers.

COURSE CONTENT

- The Health and Safety at Work Act
- Construction Design and Management (CDM) Regulations
- Risk assessments/method statements
- Behavioural safety
- Management of occupational health
- Electricity
- Working at height, scaffolding & confined spaces
- Demolition & excavations

DIRECTORS ROLE FOR HEALTH & SAFETY

WHO ATTENDS

This course is aimed at Directors and senior managers of any company, large or small.

COURSE LENGTH

This course takes 1 day to complete.

COURSE DETAILS

This CITB training course has been designed to give an understanding of the responsibilities and implications of decisions made by directors and senior management, with regards to health and safety in the workplace. The course also raises the repercussions of not meeting health and safety legal requirements, even for those not directly in a position to oversee the company health and safety policies/implementation.

The content also addresses the necessity of analysing legal responsibilities on an ongoing basis and in line with changing legislation, as well as the duties imposed on directors.

COURSE CONTENT

- Moral and human costs and the implications of decisions made in the boardroom
- The economic implications of an unsafe working environment
- Legal responsibilities with regards to health and safety
- The principles and importance the risk assessments

EMERGENCY FIRST AID AT WORK

OVERVIEW

This course gives learners the skills and confidence to respond to a range of accidents and first aid emergencies which could be encountered in the workplace.

WHO ATTENDS

This course is suitable for people aged 16+ who might need to provide first aid to someone who is injured or becomes ill at work.

COURSE SUITABILITY

This 1 day course is ideal for individuals and small to medium-sized organisations and/or low risk industries. Based on your needs, the nature of your organisation and the risks staff may face, we may instead recommend our 3 day First Aid At Work Course which provides a more comprehensive understanding of first aid.

COURSE LENGTH

This course takes 1 day to complete, running from 9am until 5pm.

COURSE DETAILS

Delivered in a classroom setting, this course offers a practical, hands-on approach that delivers the skills and confidence to use first aid skills in a real life situation.

CERTIFICATION

On successful completion of this course, you will receive a first aid at work certificate which is valid for three years by the British Red Cross. This course meets the requirements specified by the Health and Safety (First Aid) Regulations 1981.

Learners will develop the skills to help someone who is:

- Unresponsive and breathing
- Unresponsive and not breathing, including how to use an automated external defibrillator (AED)
- Bleeding heavily, choking, or burnt
- Having a seizure
- Suffering from shock

The course also includes information on:

- Assessing and monitoring a casualty
- Where to get help
- Electrical incidents
- Accident recording and reporting
- The control of substances hazardous to health (COSHH)



FIRST AID AT WORK

OVERVIEW

This course covers treatment for a variety of injuries and medical conditions that could be encountered in the workplace, providing learners with a more comprehensive understanding of First Aid including the topics covered on Emergency First Aid At Work.

WHO ATTENDS

This course is suitable for people aged 16+ who might need to provide first aid by responding to a wide range accidents, injuries and illnesses that they could encounter in their workplace.

COURSE SUITABILITY

This 3 day course is ideal for large organisations, high risk industries (e.g. construction) and organisations which have staff with known medical conditions.

COURSE LENGTH

This course takes 3 days to complete, running from 9am until 5pm.

COURSE DETAILS

Delivered in a classroom setting, this course offers a practical, hands-on approach that delivers the skills and confidence to use first aid skills in a real life situation.

Each learner is assessed throughout the course using a range of practical demonstrations, question and answer sessions, quizzes and engaging activities designed to coach and support them. The HSE requires 18 contact hours for this course, and learners must attend all sessions to be eligible for assessment.

To ensure you get the most effective learning experience, learners must be physically able to participate and we limit group size to 12 people. Each learner receives a training pack including a host of resources to help them practice the skills covered. The pack includes a course companion workbook, first aid manual, bandages and more.



CERTIFICATION

On successful completion of this course, you will receive a first aid at work certificate which is valid for three years by the British Red Cross. This course meets the requirements specified by the Health and Safety (First Aid) Regulations 1981.

FIRST AID AT WORK REFRESHER

The two-day refresher course brings your First Aid knowledge up to date, building on the material on the original course as well as giving you a thorough overview of the legislative changes and their impact in the workplace.

COURSE CONTENT

Learners will develop the skills to help someone who:

- Is unresponsive and breathing
- Is unresponsive and not breathing, including how to use an automated external defibrillator (AED)
- Is bleeding or has burns
- Feels faint or is suffering from shock
- Is choking or has been poisoned

- Has a head injury
- Has hypothermia or heat exhaustion
- Has an injury to a bone, muscle or joint (including spinal injuries)

Learners will also be able to help a casualty who is having a:

- Seizure
- Heart attack, including the administration of aspirin
- Angina attack
- Stroke
- Asthma attack
- Severe allergic reaction
- Diabetic emergency

The course also includes information on:

- Assessing and monitoring a casualty
- · Where to get help
- Electrical incidents
- · Accident recording and reporting
- The control of substances hazardous to health (COSHH)

FORESTRY FIRST AID





OVERVIEW

This course provides learners with the knowledge and practical competencies needed for the treatment of injuries and diseases that could occur whilst working in a forestry/agricultural specific environment. It's designed to accompany a regulated First Aid at Work or Emergency First Aid at Work qualification and has been specifically developed to meet the recommendations of the Forestry Commission First Aid at Work Policy.

WHO ATTENDS

The Level 3 Award in Forestry First Aid qualification is ideal for those who work (or intend to work) in a forestry, agricultural or remote environment, such as tree surgeons and farmers.

COURSE LENGTH

This course takes 1 day to complete, running from 9am until 6pm each day with a lunch break.

CERTIFICATION

The qualification is valid for 3 years. To requalify, learners will need to complete the full course again. It is recommended that the learner attends annual refresher training.

COURSE DETAILS

Delivered in a classroom setting, this course offers a practical, hands-on approach that delivers the skills and confidence to use first aid skills in a real life situation.

Each learner is assessed throughout the course using a range of practical demonstrations, question and answer sessions, quizzes and engaging activities designed to coach and support them. The HSE requires 8 contact hours for this course, and learners must attend all sessions to be eligible for assessment.

To ensure you get the most effective learning experience, learners must be physically able to participate and we limit group size to 12 people. Each learner receives a training pack including a host of resources to help them practice the skills covered. The pack includes a course companion workbook, first aid manual, bandages and more.

- Recognise and treat effects of extreme cold and heat
- Recognise and manage the effects of a crush injury
- Recognise critical time factors associated with crush injury
- Recognise the signs and symptoms of and manage adder snake bites
- Recognise catastrophic bleeding and treat using direct pressure, a tourniquet and haemostatic agents
- Recognise the signs and symptoms of and treat Lyme Disease

ASBESTOS AWARENESS

WHO ATTENDS

This course provides a comprehensive introduction to the dangers of working with asbestos, ensuring staff are appropriately trained in order to work safely.

COURSE LENGTH

This course takes three hours to complete.

COURSE DETAILS

The information covered in this course is presented at an awareness level for anyone who needs to understand what asbestos is and what is generally required in law.

It does not cover the legal requirements to carry out work with asbestos.

ASBESTOS: KNOW THE RISKS

Around 5,000 people die per year of asbestos related diseases. Workers can easily be exposed without knowing it – either from their own activities or work tasks undertaken by other people and buildings built before the year 2000 commonly used asbestos in a variety of materials, including floors, walls, ceilings, insulation, electrical products.

- Identify the properties of asbestos and outline the history of its use
- Outline the health effects of asbestos
- Outline the types, uses and likely occurrence of asbestos and asbestos containing materials (ACMs) in buildings and plants
- Identify the main statutory provisions relating to asbestos
- Know the correct procedures to follow in an emergency
- Know how to avoid the risks of asbestos



CUT OFF SAW





WHO ATTENDS

This course is essential for delegates who are required to operate petrol-driven cut off saws in the course of their daily work.

COURSE LENGTH

This course takes 1/2 a day to complete.

COURSE DETAILS

This Site Right accredited course provides delegates with the skills and knowledge to safely operate petrol-driven cut off saws.

Accidents associated with the use of this equipment are becoming more common and this course aims to raise industry standards and minimise future injuries.

Delegates successfully completing the course will receive a Site Right approved certificate.

COURSE CONTENT

- Health & safety
- Dust and silica awareness and PPE
- Noise and hand arm vibration
- Exhaust gas and carbon monoxide
- Machine pre-use inspection and blade selection
- Fuelling and fuel safety
- Cold and hot starts
- Reactive forces, hazard awareness and machine transportation

- Increased awareness of health effects linked to cutting silicabased products
- Increased compliance with Manual Handling, COSHH, Noise,
 PUWER and PPE Regulations
- Minimise risk of injury through contact with equipment



DSE - DISPLAY SCREEN EQUIPMENT & WORKSTATION ASSESSMENTS

WHO REQUIRES ASSESSMENT

Anyone who uses display screen equipment (DSE) daily for more than an hour at a time is considered a DSE user and is required by law to have an assessment. Assessments must be taken when a new user starts work, a workstation is set-up, and when existing workstations are changed.

ASSESSMENT DURATION

This assessment takes 20-30 minutes to complete.

BENEFITS

- Comply with the Health and Safety (Display Screen Equipment) Regulations of 1992
- Address poor posture and poor working habits
- · Boost productivity and reduce staff absence
- Provides you with an audit trail
- Helps you defend Health & Safety related claims

ASSESSMENT CRITERIA

- Advice is given on your **posture** and on good work practices
- The **chair** is adjusted to meet your physical requirements
- Screen height, position and suitability is checked. The assessor will ensure you're aware of features such as brightness/contrast buttons
- Good **keyboard and mouse** use and suitability is addressed.
- Desk height, space and management is assessed and advice given
- Issues regarding screen text size and keyboard readability are assessed
- The assessor will check your working environment including heating, ventilation, cabling, glare and access
- Advice on the safe use of laptops and using correct accessories is given



N703 - FIRE WARDEN





WHO ATTENDS

This course will give you foundation training and assessment in undertaking Fire Warden duties and is suitable if you have received no formal instruction or if you wish to refresh your skills.

ENTRY REQUIREMENTS

You must have a good understanding of spoken and written English. Please contact us if you have any concerns in this area.

If you require your NPORS Operator Card to include the CSCS logo, you must have passed a CITB Health, Safety and Environment (HS&E) test no more than two years before attending this course.

CERTIFICATION

Certification for this course is valid for 5 years.

COURSE DETAILS

This course provides delegates with the knowledge and skills that will enable them to safely and competently carry out the role of a Fire Warden. The course is delivered through a combination of classroom-based tutorials and practicals and you will be assessed through theory and practical tests.

COURSE CONTENT

- The basic principles of fire safety
- What fire is and how it spreads
- Assessing fire risks
- Fire prevention
- Controlling the effects of fire if they start
- Means of extinguishing a fire
- The role of a Fire Warden
- Emergency procedures and means of escape



MANUAL HANDLING

WHO ATTENDS

If you work in a controlled environment, this course is for you. It is especially important if you are carrying out repetitive tasks that involve manual handling.

COURSE LENGTH

This course takes 1/2 a day to complete.

COURSE DETAILS

It is important that manual handling is done correctly to avoid injury. Taking this assessment will give you the practical knowledge you need to understand the risks involved if you handle items incorrectly.

This is a half day course but in that time you'll learn the skills of manual handling with background theory and practice involving the types of injuries caused by incorrect handling and how to stay safe when performing tasks.

COURSE CONTENT

- Manual handling and the law
- The musculoskeletal system and mechanics of movement
- Types of manual handling injuries
- Risk assessment and control measures for risk reduction
- Principles of safer handling
- Manual handling equipment

- Learn how to safely lift, minimising risk of injury
- Gain awareness of parts of your body that are at risk of injury due to poor handling techniques and understand common injuries and how they occur
- Better recognise the hazards of manual handling and how to help reduce them in your workplace



RISK ASSESSMENT

WHO ATTENDS

The risk assessment course is aimed at managers, supervisors and persons responsible for producing, reviewing and amending risk assessments.

COURSE LENGTH

This course takes 3/4 of a day to complete.

COURSE DETAILS

This short course has been designed to provide an awareness of the duties of both employers and employees under the Management of Health and Safety at Work Regulations 1999.

The course is delivered in the classroom and involves a practical session including risk assessing a wide range of activities the delegates are familiar from within their own work environment.

COURSE CONTENT

- Overview of the Management of Health and Safety at Work Regulations 1999
- Understand the importance of risk assessments
- Understand the principles of controlling risks
- Understand how a risk assessment is undertaken

- Recognise and control hazards in your workplace
- Create awareness among your employees
- Set risk management standards based on acceptable safe practices and legal requirements
- Reduce incidents in the workplace
- · Save costs by being proactive instead of reactive

VEHICLE MARSHAL

WHO ATTENDS

WORK AT HEIGHT



WHO ATTENDS

The Work At Height short course has been designed to increase awareness of the dangers of working at height and how to safely wear a full body harness.

You will be assessed by an occupationally competent and qualified assessor and will be required to produce a Portfolio of Evidence showing how you have met the performance and knowledge criteria for each unit required within the qualification.




